

PROS EXPORTING INFORMATION

1. Overview

Software and related services and technologies offered by PROS are subject to U.S. export rules known as the Export Administration Regulations (EAR) and enforced by the U.S. Department of Commerce Bureau of Industry and Security (BIS). Additionally, the Office of Foreign Assets Control (OFAC) of the U.S. Department of the Treasury administers and enforces economic sanctions against certain countries and regimes, terrorists, and other threats to U.S. national security, foreign policy or economic interests. 3. Prohibited End-Users and End-Uses Under U.S. Law

Regardless of classification, PROS products, services, and technologies are not to be exported, reexported, or transferred to, or used or accessed by:

- Belarus, Cuba, Iran, North Korea, Russia, Syria, the Crimea region of Ukraine, the Donetsk People's Republic region of Ukraine, or the Luhansk People's Republic region of Ukraine.
- Any company or other entity located or headquartered in Belarus, Cuba, Iran, North Korea, Russia, Syria, the Crimea region of Ukraine, the Donetsk People's Republic region of Ukraine, or the Luhansk People's Republic region of Ukraine.
- Any national or resident of Belarus, Cuba, Iran, North Korea, Russia, Syria, the Crimea region of Ukraine, the Donetsk People's Republic region of Ukraine, or the Luhansk People's Republic region of Ukraine.
- Any military end use in Belarus, Burma, Cambodia, China, Cuba, Iran, North Korea, Russia, Syria, or Venezuela.



- Any military end user in, or of (wherever located), Belarus, Burma, Cambodia, China, Cuba, Iran, North Korea, Russia, Syria, or Venezuela.
- Any entity, individual, or others with whom transactions (and/or transfers to) are prohibited under applicable
 export control and sanctions laws, including those listed on any applicable sanctioned party lists (e.g., OFAC
 Specially Designated Nationals (SDNs) and Blocked Persons lists, OFAC Sectoral Sanctions Identifications
 Lists, BIS Denied Persons List, BIS Entity List, BIS Unverified List, etc.).

Further, a party may not use or transfer PROS' products, services, or technologies for use in, or with any other prohibited end-uses or prohibited end-users, including, among others, chemical or biological weapons, sensitive nuclear end-uses, or missiles (including unmanned aerial vehicles).
